- Discussion on virtual conference all day conference doesn't seem like it would work well. International
  conference is week after next, Susan is attending so we will get good feedback on its success/attendance/lessons
  learned.
- Susan reached out to Alabama Chapter, who surveyed members. 70% of responses said yes to attend virtual conference, depends on cost, agenda, speakers. Another option is to host a virtual conference with live in-person speakers, but have it streamed for others to attend virtually. Gulf Power building is off-limits right now, so that venue is not available and we don't know when it will be available.
- Keep virtual conference on the table with a September timeframe. Make decision in July. Half-day virtual conference with shorter presentations, using Whova app. Need to decide on a cost, sponsorships (using Whova).
